## 1. READ BEFORE PURCHASE AND USE

## 2. ACCEPTING THE EULA

By purchasing and by using any Andreas Instrument Sounds product(s) you, the End User (hereinafter “you”, “your”), agree to this EULA. Andreas Instrument Sounds AB reserves the right, at its full discretion, to modify this EULA at any time.

## 3. INFORMATION ABOUT ANDREAS INSTRUMENT SOUNDS

Andreas Instrument Sounds product(s) are provided by Andreas Instrument Sounds AB, Swedish Corporate Identity Number (organisationsnummer) 559381-3941, Ludvika, Sweden.

Andreas Instrument Sounds is a registered Trademark at the European Union Intellectual Property Office (EUIPO) and in other countries.

## 4. GENERAL
